

## 1. Number of current Nova Roman citizens in your provinces.

There are believed to be at least 21 citizens in the province; actual data is not available.

### 2.2. Average number of Nova Roman citizens posting per month.

From April 2021 (MMDCCCLXXIV) – March 27<sup>th</sup>, 2022 (MMDCCCLXXV):

NovaBritanniaProvincia – 3 citizens

#nova-britannia channel – 1/6 (approximately 0.167) citizen

Nova Britannia Facebook – 0 citizens

Nova Britannia MySpace – 0 citizens

TOTAL – 3 1/12 (approximately 3.083) citizens (*Note that averages for individual fora add up to more than total average because one citizen posted in two fora during one month.*)

### 2.3. Total number of members (citizens and peregrini combined) in the provincial forum.

As of March 27<sup>th</sup>, 2022 (MMDCCCLXXV):

NovaBritanniaProvincia – 26 members

#nova-britannia channel – N/A (*as individual channels do not have "members" per se*)

Nova Britannia Facebook – 4 people "like" / 4 (*presumably the same four*) "follow"

Nova Britannia MySpace – Page is connected to 4 people / 3 people are connected to page

TOTAL – 26 – 34 (*degree of overlap between membership of various fora is unknown*)

## 3. Number of those real life gatherings in the reported period in which at least 5 citizens of the province participated.

None. However, there were a total of three remote meetings and one in-person meeting. In each of these, 3 Nova Roman citizens participated, although this sometimes included non-residents of Nova Britannia.

## 4. Reenactment groups that officially cooperate with the province (friend, allied, or fully Nova Roman legions; allied or fully Nova Roman gladiatorial groups).

Legio III Cyrenaica (<https://www.facebook.com/LegionIIICyr/>) continues to be our allied reenactment legion. They have recently (March 25<sup>th</sup>, 2022) outlined a plan of activity for 2022, which has been shared with our citizens through our main forum.

## 5. Names of all candidates for the governorship.

The sole citizen of the province to step forward as a candidate for governor\* is Sibylla Ambrosia Fulvia (Citizen # 275 – the Album Civium arranges her name differently, presumably for reasons of historical accuracy). She has long been an important part of the province’s activities, organizing the MithraCon (<http://www.mithracon.org/wp/>) conference in New Haven for over 20 years until it was placed on hold due to the start of the coronavirus pandemic in 2020 and hosting numerous smaller gatherings in her own home. Sibylla is a patrician and equestrian, having been awarded the latter status of for her previous contributions to Nova Roma. She has self-published several books, including on Norse mythology, Norwegian folk medicine, and most relevantly The Divine Thunderbolt: Missile of the Gods ([https://www.auntiearwenspices.com/store/p156/The\\_Divine\\_Thunderbolt%3A%C2%A0\\_Missile\\_of\\_the\\_Gods.html](https://www.auntiearwenspices.com/store/p156/The_Divine_Thunderbolt%3A%C2%A0_Missile_of_the_Gods.html)) which includes some of her research into Roman mythology and iconography. She has previously served in a leadership role for the Society for Creative Anachronism and gained experience which would be useful for one of Nova Roma’s governors in the process. Furthermore, she is kind and amiable person, with many friends in and outside the province. Please confirm her as governor.

\* I moved to Tennessee approximately one month ago, so prorogation of my term would not be practical.

## **6. Request for Waiver**

During the term to which this provincial report was applicable, there were multiple spikes in coronavirus cases and deaths of varying intensity in different regions of this province. Some New England states continued to limit gatherings and interstate travel at the start of this time period (see articles attached to the same email as this report); although many of these restrictions were relaxed by mid-2021, the spread of new and more contagious variants made in-person gatherings appear less than prudent, even in times and places in which they would be legal.

On February 20, there was one in-person gathering. My request that masks be worn and social distancing be observed discouraged at least one person from attending. It is possible that these precautions were excessive or unnecessary: in that case, please absolve the province of any inactivity which may have resulted from my fear for my own safety and that of our other citizens.
